10 INTRODUCTION

11 Plaintiff filed the complaint on 03/29/23 (Dkt. 1). Docket Document #7 is an order
12 granting Motion for Leave to Proceed In Forma Pauperis, signed by Judge Steven P Logan on
13 04/3/23. Docket Document #9 describes Plaintiff's attempts to request waiver of service.
14 Plaintiff motioned for service by U.S. marshals (Dkt. 12) and the motion was granted (Dkt
15 14). Docket Document #15 describes attempts by U.S. marshals to obtain waiver of service
16 and subsequent service in person. Defendant was granted a motion for extension of time to
17 file an answer (Dkt. 20) by August 25, 2023 but has failed to do so.

20 RULE 55 (A) AUTHORIZES ENTRY FOR DEFAULT WHEN PARTY FAILS TO PLEAD
21 OR OTHERWISE DEFEND

22 Rule 55 provides as follows:

23 **Rule 55. Default; Default Judgment**

24 (a) **Entering a Default.** When a party against whom a judgment for affirmative
25 relief is sought has failed to plead or otherwise defend, and that failure is shown
26 by affidavit or otherwise, the clerk must enter the party's default.

1 Pursuant to this rule, Plaintiff requests that a default be entered for Defendant's failure
2 to plead or otherwise defend as ordered by the court (Dkt. 20).
